Contract STALLION SERVICE / SHIPPED COOL SEMEN

This certifies _____, herein referred to as Mare Owner, has engaged into this contract with CS Acres/Phil & Sue Drawdy herein referred to as Breeder for one breeding to the stallion **Rock N Roll Mister Apha. Reg. # 738956** for the mare _____, Registration # _____ Breed ___APHA / AQHA___ for the 2008 season for a total stallion fee of \$750.00. A \$250.00 non-refundable payment secures you breeding for the 2008 season. This \$250.00 payment will be deducted from the stallion fee.

This service is subject to the following terms and conditions:

The Stallion fee, shipping fees, credit card information are to be paid in full along with a copy of mare papers, contract signed and executed by both parties before we ship semen. There are no verbal guarantees or commitments. All monies must be paid in advance. This contract is non-assignable.

The stallion Owner agrees to ship cooled semen from the above-mentioned stallion to the mare owner the fastest way possible selected by the Peterson & Smith Reproduction Center using Fed-Ex, UPS , ect. Shipments will cost the mare owner \$200.00 ground and \$400.00 air. Check with Peterson & Smith to see collection days and time of notice for shipment.

The mare owner is also responsible to insure that the mare to be bred is properly prepared for breeding: This shall include a clean bill of health from a licensed veterinarian. Mare should be under lights and cycling properly. The mare owner shall send the contract back signed with all proper information fill out, a check for the Stallion Fee plus the first shipping fee. The mare owner's veterinarian will be monitoring the above mention mare for ovulation. The mare owner's veterinarian will communicate with Peterson & Smith for shipment of semen. The mare owner accepts full responsibility for shipping the semen container back to P & S regular mail. There will be a charge fee of \$28.00 assessed for not returning the semen container. Communication between Mare owner's veterinarian, mare owner and P & S is essential. The mare owner agrees to breed only the mare booked and not use the semen to breed any other mares. In the event the mare to be bred does not settle, the mare owner will hold the stallion owner harmless.

NO EXCEPTIONS

Live Foal Guarantee. Live foal means the foal shall stand and nurse. It is understood that if the mare proves barren, aborts her foal or if the foal is stillborn, a one time return season will be guaranteed the year after you enter into contract with CS Acres, providing proper notification is given. Proper notification shall be defined as follows: Written certification by a licensed veterinarian within three days that the mare has slipped or produced a non-viable foal. Live foal guarantee on the before mentioned stallion is as follows: C.S.Acres will re-breed the same mare for a \$250.00 return fee plus applicable shipping fee.

Color Guarantee. If this breeding results into a breeding stock colt. We will rebreed the same mare the same year she foaled for a \$250.00 return fee plus applicable shipping fee. This offer is only good for the year the mare produces a solid colt. There are no guarantees on breeding stock fillies.

Season and conditions

The breeding season in force for this contract shall begin February 1 and closes May? Of the year covered by this contract. It is further agreed that should the above named stallion die, or become unfit for service: or if the above named mare dies during the breeding season, the mare owner may substitute another mare or breed the above named mare to another stallion on the farm that is agreed to by both mare owner and stallion owner. A breeder's certificate will be issued to the mare owner after all expenses have been paid in full and upon notification of the birth of the foal. At the stallions owners digression CS Acres may refund the refundable part of the stallion fee and terminate this agreement at any time. There is a limited number of outside mares via shipped semen that we accept. So we recommend that you sign and return this as soon as possible with all applicable fees. CS Acres is aware of the high cost of collecting and shipping semen. We want your mare in foal on the first shipment. We are managing our horse to his fullest potential. We prefer you take your mare to an established breeding farm or reproduction facility. This most likely will save you and us money, time and our relationship.

Stallion Auction Breeding purchased at a stallion service auction is only good for year that the auction sold it. Stallion Auction Breeding cannot be carried over year to year for any reason. There is no color guarantee with Stallion Auction Breeding. We must have a written notice from the stallion service auction management that all fees and charges have been paid in full before we ship semen to you. Applicable shipping fee, and a contract signed and a copy of mares papers we must have before we ship semen.
